20/85 Planning applications

211272 -Cherry Tree Cottage, Park Lane, Langham Colchester CO4 5NN

Proposed temporary siting of mobile home for the duration of building works to be carried out following planning permission 210300 for a period of a maximum of 24 months.

The proposed temporary mobile home would be sited unobtrusively at the rear of the property and not visible from a public place. No objections

211317 – 4 Wick Terrace, Laurels, Wick Road, Langham CO4 5PF

Proposed front porch and first floor rear extension.

The proposed first floor extension and porch are in keeping with the rest of the property. We note that a south-facing bedroom window overlooks the neighbouring property Bodinnick. Other than this we have no objections.

211329- Oakview, School Road, Langham Colchester CO4 5PA

Application for approval of reserved matters following outline approval 172118 -

APP/A1530/W/18/3200940 – Demolition of bungalow and barn/shed and the erection of 3no. Dwellings.

The original application 172118 was objected to by the Parish Council and refused by the Borough Council as the responsible planning authority. The appeal against refusal was upheld by the Planning Inspector. No objections.

211603 - 2 Low Lift Cottages, Langham Colchester CO4 5QA

Single storey rear extension and internal alterations.

We note that there may be a potential question of light with the neighbouring property. Other than this we have no objections.

## 20/86 Vistry Homes Ltd – all conditions pertaining to application 191830

All councillors are available to attend the meeting with CBC on 30<sup>th</sup> June 2021. The PC had asked for a face-to-face meeting but CBC are only meeting via zoom at the moment. There is a meeting with Sir Bernard Jenkin this Friday 18<sup>th</sup> June with LPC Councillors and other constituents to discuss the Langham Water Recycling Centre (WRC) and its associated sewerage network.
